Anne-Françoise Morel is associate professor in history of architecture at the KU Leuven, dept. of Architecture. Her research focusses on architecture, symbolic practices and the construction of identity. Her book "Glorious Temples or Babylonian Whores: the Architecture of Church Buildings in Stuart England through the Lens of Consecration Sermons" was published by Brill (Leiden) in 2019 and was shortlisted for the Society of Architectural Historians of Great Britain's Alice David Hitchcock Medallion.

Besides a degree in Art History, Morel also holds a degree in Cultural Diplomacy. She is co-supervisor of the research project 'Designing Embassies for Middle Powers: The Architecture of Belgian and Dutch Diplomacy in a Globalizing World' (with prof. F. Floré, PhD researcher B. De Maeyer and supervisor of 'Housing the Nation Abroad: the Belgian Diplomatic Representation through Architecture and Interior Representation, 1831-1940' (with prof. Floré, PhD researcher C.
